ENTRY FEES. £ 10.00 Membership Fee £5.00

COURSE Entirely on private land, approx 2 miles per lap & includes 6 observed sections. Event will last approx. 2 hours & the rider who completes the most laps will set the standard time, which must not exceed 20mph average. Riders who exceed speed average, miss sections or cut the course will be disqualified. Riders will start in pairs at 10 second intervals in numerical order.

MARKING: Clean = 0, Footing= 3, Stop = 5, Missed Section = 5, Course Cutting = Exclusion.

TIES: Fastest overall time, then the highest number of cleans.

PROTECTIVE CLOTHING, Boots, Helmet & gloves must be worn.

PROTESTS, In accordance with the NSC of the ACU to Secretary of the Meeting within 15 days.
